# **Las Vegas Intertribal Powwow Liability Waiver and Hold Harmless Agreement**

The undersigned hereby agrees to hold harmless and indemnify the Las Vegas Intertribal Powwow committee, sponsors and affiliates, Clark County, Nevada and all its departments, and the Clark County Parks and Recreation Department, and State of Nevada Parks from all liability that may be caused, either directly or indirectly by the actions of the undersigned during the Las Vegas Intertribal Powwow. The undersigned further agrees to be wholly responsible for all applicable taxes due for the sale of goods by the undersigned during said event and agrees to have all applicable required vendor permits. If vendor is operating a food booth, vendor agrees to have all the required permits and be set-up in a timely manner to facilitate inspection by the Clark County Health Department. The Las Vegas Intertribal Powwow Committee retains the rights to the sale of water and energy drinks. Food vendors may sell soda pop and hot drinks only.

Vendor also acknowledges that if the fees are not paid in full by cashier's check or money order by 30 days before the event he or she will NOT be allowed to set up the booth. No cash will be accepted for booth rental.

The undersigned also further agrees that he or she shall be solely responsible for any and all liability to any others that may incur from the actions of the undersigned or his or her agents during the operations of the Las Vegas Intertribal Powwow. It is also understood that the above entities are not held responsible for the actions of the attendees nor does it guarantee minimum sales or weather conditions. No refunds will be given due to inclement weather. This is considered a rain, wind, or shine event. Please be prepared for all weather conditions. No fees will be refunded after 45 days before the event. The undersigned further acknowledges receipt of and agrees to abide by the Rules and Guidelines provided.

## Guidelines and Rules

### Who is eligible to apply?

- ◆ Vendors selling native arts and crafts must possess at least 1/4 Indian blood, any exceptions must be approved unanimously by the Powwow Committee.
- ◆ All vendors must supply own generators.
- ◆ Limited parking for vendors behind booth space (1 Vehicle only).
- ◆ No electrical outlets are available.

### How Do I apply?

Submit a completed application and cashiers check or money order check for total amount.

### Application requirements:

- ◆ Complete and return application and signed Liability Waiver.
- ◆ Make Copies of what you signed for your records.
- ◆ Total Booth Fee in Cashier's Check or Money Order
- ◆ No Cash or Personal/Business Checks Accepted
- ◆ Food Vendors are responsible for all contact with the Clark County Public Health Department.

### All vendor applicants must meet the requirements and be accepted by the Las Vegas Intertribal Powwow committee. Security and Liability

Although Las Vegas Intertribal Powwow provides security in the vendor area, it is the sole responsibility of the individual vendor to maintain adequate security and insurance coverage for the property in his/her booth. Las Vegas Intertribal Powwow accepts no responsibility for loss, theft or damage of artists' property. No refunds will be given due to inclement weather. This is considered a rain, wind, or shine event.

### Vendor Rules:

- ◆ The Las Vegas Intertribal Powwow Committee retains the rights to the sale of water and energy drinks. Food vendors may sell soda pop and hot (coffee, cocoa, tea) drinks only.
- ◆ Vendors must provide own tables, chairs, and table skirting and all equipment needed to safely operate their booth and comply with the local health ordinances.
- ◆ Booth must be authentic for the period and all tables covered to ground level.
- ◆ Vendors or their assistants must work at the booth during all official hours of operation.
- ◆ Manufactured, imitation crafts and craft items and objects made from commercial kits or patterns are strictly prohibited.
- ◆ All work must be properly represented to the buyer. All items for sale must be clearly priced. All original artwork must bear signature or hallmark of the artist.
- ◆ Vendors reproducing their work may sell reproductions, however, items must be clearly labeled as "reproduction."
- ◆ Booth space is available for pre-selected vendors only. No walk-ins will be allowed and booths must be paid for 30 days in advance.
- ◆ Vendors may not display or sell any items that contain materials derived from animals which are considered endangered or might otherwise be considered in violation of local, state, and/or Federal laws.
- ◆ No animals are allowed in booths, except guide dogs.
- ◆ Any vendor who misrepresents himself/herself or his/her work to Las Vegas Intertribal Powwow, or who does not abide by the terms and conditions as set forth will be removed from the event and will not be allowed to participate in future years.
- ◆ All vendors must conduct themselves in a manner that reflects the dignity of the event.
- ◆ Use of alcohol or any other illegal substances by artist exhibitors, food vendors or their assistants is prohibited. Failure to follow these rules will result in removal from the event with no recourse.
- ◆ All food vendors must comply with the local food service health ordinances and take every precaution to insure the food they sell is wholesome and safe.
- ◆ Tobacco & Alcohol Sales are prohibited on Clark County Parks Grounds.
- ◆ Fireproof Tent and Fire Extinguisher
